Scholarships

Deadline

Applications must be **postmarked by March 10, 2017**, and mailed to:

Eligibility Requirements

1. Applicant must be a United States citizen.
2. Applicant must be a Highmark Credit Union member.
3. Applicant must be a graduating high school senior.
4. Applicant must be planning to attend a two or four year post-secondary accredited university or a technical/vocational school.

Application Requirements

1. A completed copy of the Highmark CU High School Financial Scholarship application form, including:
 - a. List of volunteer work/job experience
 - b. List of extracurricular activities/organizations
 - c. List of accomplishments, honors, and awards
2. A written letter of recommendation from a teacher, counselor, community leader or supervisor.
3. An essay, not to exceed 500 words, on the following question:
“What can your credit union do to continue providing you with financial solutions for a lifetime?”

Judging Criteria

The judging committee will score each applicant based on the following criteria:

1. Volunteer work/job experience
2. Extracurricular activities/organizations
3. Accomplishments, honors and awards
4. Letter of recommendation
5. Essay
